I wish to inform that, the Government of Andhra Pradesh has requested the Government of India to kindly sanction disease reporting units for all the 1128 Mandals in Andhra Pradesh state under NADRS scheme (vide reference 2nd cited). In this regard, the Government of India has sanctioned NADRS units to 1097 mandals only and 31 mandals were left uncovered under the NADRS scheme.

Further, I am to inform that in Andhra Pradesh state there is four tier administrative system i.e., Mandal, Division, District and state.

The Government of India has allotted units for Mandal, District and state level. In this regard, the implementation of the scheme will be effective if the disease reporting units are provided to the Divisions also. There are 81 Divisions in the state and additional 81 units may also be sanctioned to Andhra Pradesh state.

Therefore, I kindly request the Government of India to allot NADRS units to the left over 31 mandal and also for the 81 Divisions i.e., total of 112 units may please be sanctioned to Andhra Pradesh state at the earliest for effective implementation of the scheme.
